## No to disbanding the Supreme Judicial Council

Following the President's resolution, yesterday evening, Monday, February 07, in his meeting with the Head of the Government, to dissolve the Supreme Judicial Council and to replace it by a temporary body under a decree that will be issued soon assembling all powers in a complete breach of the principle of the separation of powers.

In the midst of the exceptional situation and the exceptional measures that emerged from it, most notably the presidential decree No. 117-2021, which concentrated the legislative and executive powers in the hands of the President, and after the President's unprecedented retreat from the constitutional achievements as well as his quest to subject the judiciary to the executive authority under a system in which all authorities are combined in his hand.

## It is important for the organizations and associations listed below to express:

- 1- Their principled rejection of any interference by the executive authority in the work of the judiciary.
- 2- Their reminder that despite all the fadings that have accompanied the Coucil's work since its election, it remains the only structure guaranteeing the institutional independence of the judiciary in accordance with the Constitution, which has accorded the Council the financial and administrative independence and self-management in a precedent of its kind.
- 3- Their claim for a structural reform to the judicial system, however such reform could not be achieved by concentrating all powers in the hands of one person during an exceptional situation in which the pillars of the rule of law and its defenses emanating from an elected legislature and a constitutional court are absent.
- 4- Their renouncement of misleading the public opinion in terms of considering the Supreme Judicial Council solely responsible for deciding cases, as the Council is not a court, nor does it issue judgments, and only considers referred cases from the inspection body directly oversighted by the Ministry of Justice, then only takes disciplinary decisions, and in turn forwards the cases to the Public Prosecution if necessary.
- 5- Their condemnation of the direct threat posed by the President to a constitutional institution that has been established following a participatory process and after the judges' struggles and professional structures.
- 6- Their rejection towards both the subjugation of the executive power to a verbal speech pronounced by the President of the Republic and to the security forces surrounding the council's headquarters and preventing employees from performing their duties in a complete absence of any legal basis or arrangement.
- 7- Their call on all the forces defending democracy and the state's civil society, including civil society organizations, to unite efforts and renew their commitment to defending the constitutional and independent bodies as a cornerstone in the democratic building that Tunisia has pursued, and to put an end to the repeated abuse affecting them.
